Dear Speaker Pelosi, Majority Leader Hoyer, Whip Clyburn, Chairman Larson and Vice Chairman Becerra:

As the House and Senate move toward passage of final legislation that will improve the quality and reduce the cost of health insurance in America, I urge you to include these priorities, which are especially important to the people of central New Mexico.

I continue to support a strong public option and I consider reconciliation an acceptable means to accomplish this goal. We can simultaneously reduce the deficit and avoid raising taxes by including the public option. The Congressional Budget Office estimates that the public option will save taxpayers between \$25 billion and \$110 billion, and will save billions more when private insurance corporations compete to bring down premium costs.

I am concerned that the excise tax included in the Senate legislation would impede innovation, limit access to life-saving medical technology, and lead to job losses in the medical device industry. I am particularly concerned about the impact this tax would have on a facility in my district that manufactures surgical equipment. The facility, which employs over 650 New

Mexicans, competes directly with two plants in Juárez, Mexico. The additional burden of an arbitrary excise tax would hamper its ability to compete and could threaten these well-paying jobs. I am fighting hard every day to keep and create jobs in New Mexico and in the United States. Health insurance reform should not run counter to these efforts.

I remain concerned about a proposal in the Senate-passed legislation to tax high-value health insurance plans. Real life experience has clearly shown us that this tax will most likely be passed along to insurance consumers. For New Mexico's working families that have forgone salary increases in exchange for strong insurance benefits, the cost thresholds for taxation are simply too low. As health insurance costs continue to increase at a rate greater than inflation, more and more middle-income New Mexicans would be forced to pay this tax.

Finally, as we reform our nation's health insurance system, we cannot forget our treaty obligations to Native Americans. As you know, I successfully secured the language to incorporate the Indian Health Care Improvement Act (IHCA) in the House version of the health insurance reform bill. The IHCA would sustain, expand, and modernize the Indian Health Service, which provides comprehensive health services for Native Americans.

I look forward to working with you to pass health insurance reform legislation that will reduce the deficit, reduce the cost of insurance, and improve the quality of care for all Americans.
