Dear Governor Richardson,



Thank you for your hard work and dedication to the state of New Mexico. Our current fiscal crisis is clearly one of the toughest challenges that our state has faced. We recognize that you are diligently working to find solutions and we applaud your efforts to do so.

We also applaud the Legislature's efforts to address this issue while protecting education, Medicaid, and other critical programs and services from harmful cuts. However, we also believe that a 7.6 percent cut for executive agencies would be very damaging. Cuts this deep would greatly inhibit agencies' ability to fulfill their statutory obligations. We believe there are other means to shore up the budget in the near-term, until a sustainable solution—including revenue enhancements—can be considered in January.

We urge you to line-item veto Section 2.A.(4) of HAFC substitute for HB17 & 33 as amended, eliminating the Legislature's requirement for aggregate agency cuts of 7.6 percent. We would also like to strongly emphasize that the subsequent subsections of paragraph (4) outlining agency and program exemptions must be observed should you consider additional executive action for budget reduction, in lieu of this section of the bill. Certainly we urge you to honor the Legislature's clear intention to hold all Medicaid funding harmless from budget cuts. As you know, we will lose \$5 in Medicaid services in order to save \$1 of state funds. The human cost of making cuts to Medicaid is just too great in these difficult times.

Again, thank you for your leadership during these challenging times. As an alliance of more than 40 faith leaders, small business owners and associations, labor unions, social advocacy groups, and nonprofit organizations we know these challenges well. Better Choices New Mexico believes that it is essential that we take a balanced approach to addressing our state's fiscal crisis. Revenue projections continue to look bleak and we believe the only sustainable solution is to consider all revenue-generating measures.
