The Domenici Victory Fund is a joint fundraising committee composed of People for Pete Domenici and the Republican Campaign Committee of New Mexico. All contributions to The Domenici Victory Fund are subject to Federal contribution limits. All contributions permissible under Federal law that would cause a contributor to exceed any applicable federal contribution limit to any specific participant will be reallocated to the remaining participant according to the formula outlined below. Any contribution that would cause a contributor to exceed any applicable federal contribution limit or otherwise not be permissible under Federal law shall be refunded to the donor. Any contributor may make his or her contribution payable directly to either of the specific participating committees.

Allocation Formula for Contributions:

- a. The first \$2,300 of any contribution by an individual or non-multicandidate federal PAC, or the first \$5,000 of any contribution by a multicandidate federal PAC, shall be allocated to the People for Pete Domenici primary election account;
- b. The next \$2,300 of any contribution by an individual or non-multicandidate federal PAC, or the next \$5,000 of any contribution by a multicandidate federal PAC, shall be allocated to the People for Pete Domenici general election account; and
- c. The remaining amount of any contribution by an individual or non-multicandidate federal PAC, or the remaining amount of any contribution from a multicandidate federal PAC, shall be allocated to the Republican Campaign Committee of New Mexico.

The Federal Election Commission requires political committees to collect the name, address, occupation and employer for all individuals whose contributions aggregate in excess of \$200 in a calendar year or in excess of \$200 in an election cycle.

Contributions are not deductible for federal income tax purposes.
